

INVITATION OF BID

Workers Welfare Fund (WWF) Islamabad, invites sealed bids from reputable Constructors / Firms (Individual) for HVAC and Lift works for the project "Dismantling and Reconstruction of Workers Welfare Fund Office/ Commercial Building at Plot No. 16, F-6 Markaz, Super Market, Islamabad" on item rates basis.

The Applicant's firm should be registered with Income Tax and Sales Tax Departments and should have valid registration with PEC in minimum Category **C-4** with field of specialization as **ME-01** and **ME-03**:

1. Bidders will be "**Post-Qualified**" on the basis of information provided with their bid. Bidders who fail to qualify in this respect shall not be considered further.

4. Single Stage – Two Envelopes Bidding Procedure will be adopted. One envelope containing Technical information of bid shall be sealed and clearly marked "**Technical Bid**" The second envelope containing the Financial Bid shall be sealed and clearly marked "**Financial Bid.**"
5. Envelop of "**Technical Bid**" should be accompanied by a Bid Security of amount Rs. 1,000,000/- in the form of original Bank Guarantee / Bank draft or Pay order from scheduled bank in Pakistan in favor of WWF, Islamabad.
6. Partial, incomplete and conditional bids will not be considered. "**Technical Bid**" and "**Financial Bid**" (both envelopes, sealed in single envelope) are to be submitted at the address mentioned below by December 23, 2021 at 11:00 Hrs. The envelope containing Technical Bid shall be opened on the same date at 12:00 Hrs in the presence of bidder(s)/bidders authorized representative(s) who choose to attend.
