1. Worker Welfare Fund (WWF) invites sealed Bids from specialized firms registered with PEC in Category C5 (minimum) with field of specialization ME-03 and duly authorized sole distributors / dealers / agency holder of Lifts in Pakistan.

2. Single Stage Two-Envelope Procedure will be adopted, one envelope containing technical information of Bid and data/ document required for Post qualification shall be clearly marked as “**Technical Proposal**”. The second envelope containing price bid clearly marked as “**Financial Proposal**”.
3. Envelope of “**Technical Proposal**” shall be accompanied by Earnest Money/ Bid Security in the form of Call Deposit or Bank Guarantee issued by a scheduled Bank in Pakistan or by foreign bank duly counter-guaranteed by schedule bank in Pakistan in favour of Worker Welfare Fund (WWF).
4. Bidders should visit the project site to get acquainted with the existing work conditions and also to get familiar with the quantum and nature of work. A joint visit to the Project site can be arranged on request.
5. A Pre-Bid meeting will be held on 30-11-2022 at 11:00 AM in the office of the Worker Welfare Fund (WWF).
6. The bids Single Stage-Two Envelope “**Technical Proposal**” and “**Financial Proposal**” prepared in accordance with the instructions in the Bidding Documents must reach at address **09-12-2022 at 10:30 AM**. The envelope containing “**Technical Proposal**” **Shall be opened on the same date at 11:00 AM** in the presence of the bidders or their representatives who wish to be present. Bids received after the prescribed time and date. Partial or incomplete Bids will not be considered.
7. Bidders will be Technically Qualified on the basis of information provided with the Bids, as per the criteria prescribed in the Bidding Documents.
8. The unopened envelopes of “**Financial Proposal**” including Earnest Money/ Bid Security of those bidders who fail to Qualify / Technical Qualify shall be returned to them. The decision of the Employer in this connection shall be final and binding on the Bidders and the Employer shall not entertain any claim on the basis of cost incurred by the Bidders for preparation of the bids.
9. The envelope of “**Financial Proposal**” of the firms of Post-Qualified and whose bids shall be Technically accepted will be opened in the presence of the bidders or their representatives at the date or time to be determined and communicated later.
